# REPRODUCTION POLICIES AND REQUIREMENTS

**DELIVERY:**

We deliver most orders within 3-5 business days. Orders for items already digitized can be fulfilled more quickly, but large orders for items not already digitized may take up to 15 business days. There is no additional fee for delivery. **Delivery Methods:** 1) via e-mail when files are small enough; 2) otherwise via file sharing (Microsoft OneDrive). All files will be provided in **JPEG format** unless specified in Special Instructions on the front of the form.

**RUSH ORDERS:**

Rush orders are available for a rush fee that doubles the reproduction fees. A rush order simply moves your order to the front of the line and they are usually fulfilled within 2-3 business days. If there are no other orders in front of yours no rush fee will be charged.

**SPECIAL OVERSIZE:**

This category is only for large items needing digitization, such as large maps, architectural drawings, or mammoth photo prints requiring special treatment.

**CREDIT OR REFUNDS:**

The Library & Archives does not give credit or refunds on its reproduction services.

**ONE USE:**

Permission will be granted for one-time use only. Any subsequent use of a digital image requires the written permission of the Montana Historical Society Library & Archives. All other rights, including those of further reproduction, are reserved in full by the Library & Archives.

**PUBLICATION /  
COMMERCIAL USE FEE:**

A permission application must be completed for publication and/or commercial use of an image.

Digital images may be cropped to suit design and layout, but they may not be altered, colorized or drawn upon without prior approval from the Library & Archives in addition to a signed permission form.

We reserve the right to refuse to provide reproductions to publishers and individuals who have not complied with our policies.
